Among the issues covered by the GR were election preparation for the 2024 Primary Election, 18,000 mail ballots started going out on April 29<sup>th</sup>, military and overseas voting services, the 6 best practices of the EAC (Election Assistance Commission), the Ballot Curing Report and the curing process, the 2025 Budget, the new Early Voting Ordinance, Check In vs. Ballots Cast Review, the "I Voted" Sticker Contest.

## VOTER REGISTRATION REPORT

After reviewing hundreds of voters challenged in Prince William County, none of the deceased or moved voters challenged attempted to vote after their relocation or death.

## NEW BUSINESS

The EB appointed over 100 new Election Officers.

PWC is finalizing a new policy on signs at Early Voting Locations.

The EB voted unanimously to modify the June Ballot Order based on a recommendation from the GR.

## CLOSED SESSION


