Uniformed Police Officers will be stationed at some polling places. Locations will be restricted to a "Need To Know" Basis. We have launched a new "I Voted" Design Competition. The Deadline to enter is March 5<sup>th</sup>. Logic and Accuracy Testing will begin in a few days.

### **VOTER REGISTRATION REPORT**

Not much new to report. This is accurate until the April 2024 Meeting. An Active Registered Voter is a voter whose record is current with the appropriate election authority and who is eligible to vote. We have 286,863. An Inactive Registered Voter is a Registered Voter who has not participated in recent elections and who has not responded to certain voter registration confirmation mailings or notices for election authorities. We currently have 31,512. We have had 9,805 New Registrations. ELECT has done 27, 807 NCOA (National Change of Address Program) mailings. Total number of Voter Cancellations is 9,248.
