POST ELECTION BOARD MEETING AND CANVASS (5 November 2025)

Chairman Scarborough called the Meeting to order at 10:13 AM, called for a Moment of Silence and then the Pledge of Allegiance. As all three Board members were present, there was a Quorum.

Motion to allow the Election Officers **to open Envelopes 2 and 2A** and begin the Canvass of the initial election results.

Initial Results Check

General Registrar Eric Olsen explained the Canvass procedure to the bi-partisan Election Officers and observers present.

Election Officers inspected and cross-checked the reported election results against the source documents submitted by each precinct.

PROVISIONAL HEARING (5 November 2025)

Motion to reconvene the Electoral Board in the Main Office Conference Room, 9250 Lee Avenue, Manassas, VA, 20110 to hear testimony from voters regarding their provisional ballots.

The Election Officers completed their work at approximately 2:55 PM. The Registrar and Board members offered closing comments and appreciation for the participating Election Officers.

PROVISIONAL BALLOT ADJUDICATION (11 November 2025)

At 10:00 AM on November 11th, the Board reconvened in the Main Office Conference Room, 9250 Lee Avenue, Manassas, VA, 20110 to adjudicate absentee ballots flagged for further scrutiny, and provisional ballots submitted during both early voting and on Election Day for the 2025 General Election.
