MINUTES FOR THE ASCERTAINMENT AND PROVISIONAL BALLOT MEETINGS
FOR THE JUNE 23, 2020 DUAL PRIMARY ELECTION

Wednesday June 24, 2020 8:00am

The Ascertainment meeting was called to order by Chairman Williams at 8:17 am and seconded by Vice Chairman Reynolds.

"Mr. Chairman – I have given sufficient notice of this meeting and the Provisional Ballot Meeting and I have the certification of the public notice requirements documents here.

The meeting was called back into order by Chairman Williams at 1:15pm, seconded by Vice Chairman Reynolds.**


