

Prince William County - Gubernatorial Elections - Registration Rate (% of Voting Age Population)






2025 Virginia Gubernatorial Election, Prince William County



2025 Virginia Gubernatorial Election for Republican Candidate, Prince William County




2025 Virginia Gubernatorial Election for Democratic Candidate, Prince William County




Prince William County - 2025 November General Election - Turnout (% of Total Registered)

SECRETARY'S REPORT

Officer Advisory Group

Met with 12 bipartisan Officers to review Officer selection, assignments, and parity

- Officers report smooth operations; limited awareness beyond precinct; unaware of party balance (as intended)

Parity Status (2025 General Election)

- Officer Parity: **93%** compliant (7 precincts short)
- Leadership Parity: **100%**
- Chief Parity (goal): 58%/42% split (16 precincts short)
- *Next: Review policy changes to improve parity*



SECRETARY'S REPORT

Strategic Goals Updates

Oversight: Letter to ELECT (Apr 2025) requesting VERIS read-only access — *no response*.

Accountability: Letter to Commonwealth's Attorney (Nov 2025); response declined prosecution due to case factors. Safeguards prevented improper ballots from being cast.

Transparency: Letter to Attorney General (Oct 2025) regarding Ballot Verifier — *awaiting response*.

Dear Commissioner Beals:

The Prince William County Electoral Board (the “Board”) is charged with ensuring that elections in the County are administered in accordance with the law, including overseeing and evaluating the performance of the General Registrar. However, the Board has no access to or visibility of the environment where a large portion of those duties are carried out—the Virginia Election and Registration Information System (VERIS).


Title 24.2 of the Code of Virginia and Title 1 of the Virginia Administrative Code define the duties of the Electoral Board and the General Registrar and prescribe the manner by which elections and associated activities shall be administered. Under the Code of Virginia, the Electoral Board appoints the General Registrar and delegates certain duties to the Registrar and the Office of Elections (VA Code §§ 24.2-106.01, 24.2-107, 24.2-109, 24.2-109.1, and 24.2-114), but retains responsibility for oversight and the annual evaluation of the performance of those duties (§24.2-109.1).


Many of the duties of the General Registrar and Department of Election staff are performed within the VERIS database (See, e.g., VA Code §§ 24.2-404 et. Seq.) including processing voter registration applications, marking and updating registration records, and performing voter list maintenance using data from internal sources and external agencies (e.g., the Secretary of the Commonwealth, Virginia State Police, Social Security Administration, Department of Motor Vehicles, Virginia Department of Health, U.S. Postal Service, State and Federal Courts, and others).

To fulfill our oversight role effectively, the Board should be granted read-only access to VERIS. This would allow the Board to retrieve reports, monitor activity in system queues, view and trace voter registration history, and otherwise review and validate actions taken within the database by the Registrar and staff—without the ability to add, delete, or modify any data. Access would remain consistent with the stipulations set forth in 1 VAC § 20-20-90 (recognizing the possibility of both restricted and unrestricted account classes).

Accordingly, the Prince William County Electoral Board respectfully requests read-only access to VERIS to ensure it can properly perform its statutory oversight duties.

Dear Attorney General Miyares,

It is the position of the Electoral Board of Prince William County that residents' confidence in our elections requires "accessibility of information at each stage of the process", and the recognition of the rights of citizens to "participate in elections and to trust that the electoral process is valid."¹

In that spirit, our Board is currently exploring the potential use of Ballot Verifier to enhance legitimacy, trust, and transparency in our electoral process. As part of that review, and in light of the relative novelty of this tool, we respectfully request your opinion regarding its permissibility under the Code of Virginia for use in our elections.

The effectiveness of this tool relies on the public availability of digital images of each ballot and the *Cast Vote Record* ("CVR")—the electronic record indicating how each scanned ballot's marks were tabulated by the machines as votes for candidates and ballot questions. Ballot images and CVRs are already captured by the standard technology used in many ballot scanners, including those deployed in Prince William County, which are manufactured by Hart InterCivic. Whether these records may be made publicly available is determined by state legislatures, election offices, courts, and local jurisdictions. Discussion has centered around the provisions of §24.2-669.

Ballot Verifier is a software platform developed by civic technology firm Civera, which utilizes the digital ballot images captured by scanners along with their corresponding CVRs. It compiles and formats this information for secure publication on the Office of Elections website. This tool enables the public to view digital images of all ballots cast in an election, accompanied by a record of how each ballot was recorded in the CVR. Users are able to filter results by election, precinct, contest, candidate, and voting method (e.g. early, absentee, or Election Day). These results can then be compared to the county's official election results submitted to and published by the Virginia Department of Elections.

Ballot Verifier is currently used in Ada County, Idaho, and Tarrant County, Texas. Other jurisdictions—including Los Angeles County, CA; Dane County, WI; Maricopa County, AZ; several

Colorado counties; and jurisdictions in Kentucky, Washington, Arizona, and New England—employ other tools to make CVRs and/or ballot images publicly available.

Currently, Prince William County posts results tapes online after each election, allowing voters to compare results reported on the state website against the official precinct-level documentation generated by the ballot scanners. We are also considering the implementation of thermal imprinters—an optional accessory for Hart InterCivic's Vanguard ballot scanner designed to enhance *risk-limiting audit* (RLA) capabilities. After a ballot is cast, the imprinter applies a randomized code—the *Imprint ID*—to each ballot. This identifier is included in the corresponding CVR. In *Results*, Hart's tabulation module, the Imprint ID associated with each CVR is included in reports generated by the *Results Auditing Dashboard*, enabling and streamlining ballot-level auditability.

Expanding these practices to include online access to CVRs and ballot images through Ballot Verifier would allow any citizen or organization to conduct a full, independent and self-guided audit of each election, effectively “turning [...] a black box into a glass box,” as described by Civera CEO Adam Friedman.


We believe this combination of tools would set a new high bar for election transparency, accountability, and public trust—without compromising ballot secrecy or election security.

Accordingly, we respectfully seek your opinion on the legality of using Ballot Verifier technology under the Code of Virginia.

Dear Commonwealth's Attorney Ashworth,

During the 2024 General Election, the Prince William County Office of Elections identified three apparent violations of Virginia election law under Va. Code §24.2:

1. An individual that allegedly attempted to cast an absentee ballot for a deceased person;
2. A voter that allegedly attempted to vote twice; and
3. An individual that allegedly provided improper assistance to a disabled voter.



These cases were referred to your office by our General Registrar, Mr. Eric Olsen, on October 26, 2024, with supporting documentation.

Your office informed Mr. Olsen by phone that prosecution would not be pursued. However, it remains unclear whether that decision followed an investigation, a finding of insufficient evidence, or a determination without further inquiry.

The Electoral Board seeks to understand how such matters are evaluated and resolved. Accordingly, the Board respectfully requests guidance on the criteria we should use when determining when to refer cases and what information or data should be provided to the Commonwealth's Attorney's Office when considering potential election violations.

We appreciate your attention to this matter and look forward to your response.








Open DMV for 45 days for General Elections

- Motivation, issues, and candidates drive turnout by party, not early voting locations
- Continue to make data-driven, incremental suggestions to the BOCS

Participation

- 29,879 applications
- 21,775 mail ballots cast
- 73% turnout rate (+ rejects/prov. voters)
- Significant increase in early ballots returned
 - 11,200+ ballots returned in first 3 weeks
- Excellent work by the mail voting team



MAIL VOTING

Ballot Curing

When a mail ballot envelope has an issue that Virginia Code prevents from being eligible to be counted unless the voter “cures” that issue (returns a form, comes to the Office, reissued ballot, etc. are all valid “cures”)



- Pollbooks performed much better than past elections (some ID scanners need replacement)
- Difficult campaigners or observers were the most significant issues of the day for officers (but also low overall)



ELECTION DAY

Voter Credit vs. Ballots Cast

Election Day = 70 less check ins (0.08%)

Early Voting = 5 less check in (0.009%)

- Indicates highly accurate work by officers
- Indicates more experienced Early Voting officers make fewer mistakes, not pollbooks

Staffing Overview

- Our team continues to meet a complex list of required staffing, parity, officer, and Electoral Board demands to make sure officer teams are well supported
- Staffing was excellent across the board
- Officers rate the staffing team very highly

- All precincts had officers of both parties in equal number or one off (10/20 final)

STUDY ASSESSMENT

“OFFICE OF ELECTIONS This space is significantly undersized for its current needs, and relies on reserving space in adjacent buildings to meet demand. In its Lee Ave location, storage areas, office space, meeting rooms, training rooms, and public spaces are undersized. The office is utilized for early voting and does not have proper queuing or ballot storage spaces. The department also has a warehouse in Woodbridge that is also significantly undersized. Public viewing is a vital legal requirement for this department, and its current space makes meeting these requirements difficult...



STUDY ASSESSMENT

...Maintaining adequate security is a major issue for both locations. The separation of administrative and warehouse spaces creates major inefficiencies for staff as the locations are approximately 15 miles apart, and staff may need to travel between locations multiple times per day. Parking for both staff and the public is a major issue for the Lee Ave location. This department needs stay separated from any PWC departments with elected officials.


