#### POST-ELECTION BOARD MEETING AND CANVASS for the JUNE 2024 CONGRESSIONAL PRIMARY

The Board convened at 10:00AM on Wednesday, June 19<sup>th</sup>, in the Old Manassas Courthouse, 2<sup>nd</sup> Floor, 9248 Lee Avenue, Manassas, VA, 20110 to perform the Canvass for the June 2024 Congressional Primary Election. Chairman Scarborough called the Meeting to Order. Vice Chairman, Mark Dillon, was not present. A Quorum being present. We proceeded with the CANVASS.

Secretary Steverson made a Motion to allow the Election Officers and Staff to open the 2A Envelopes and the 2 Envelopes for the purpose of conduction CANVASS. It passed unanimously.

Secretary Steverson made a Motion to allow the Election Officers and Staff to open the 1Envelopes to conduct the Provisional Research to prepare for the adjudication of Provisional Ballots. It passed unanimously.

Secretary Steverson made a Motion to authorize delivery of the 3 Envelope and the 6 Envelope Ballots to the Clerk of the Circuit Court, Prince William County. It passed unanimously.

The GR, Eric Olsen, explained the Canvass Procedure to the election officers and welcomed the Party Representatives and Observers in attendance.

#### PROVISIONAL HEARING

At 12:00 PM the Board Members adjourned and reconvened in the Main Office Conference Room, 9250 Lee Avenue, Manassas, VA., 20110 to hear Testimony from voters regarding Provisional Ballots. The Motion was approved unanimously. No Voters appeared. At 12:30 PM Chairman Scarborough adjourned the session.

#### CANVASS RECONVENED

At 1:30 PM the Board reconvened the Canvass Document Check at the Old Courthouse, 9248 Lee Avenue, 2<sup>nd</sup> Floor. At 5:00 PM Chairman Scarborough adjourned the Canvass until Saturday, June 22 at noon.

#### **CANVASS RECONVENED FOR PROVISIONAL BALLOT ADJUDICATION**



#### **PROVISIONAL BALLOT ADJUDICATION and FINAL CERTIFICATION**


